#### A LETTER FROM THE CHAIRMAN

It was another busy and eventful year at NOPEC in 2023. What started as a time of uncertainty for NOPEC's electric aggregation, turned into a successful validation as the Public Utilities Commission of Ohio (PUCO) re-certified our electric aggregation in March, finding that NOPEC did not violate any Ohio laws or PUCO rules when we transitioned over half a million customers to the utilities' standard service offer during a period of extreme market volatility in 2022. Not only were our actions legal and transparent, but they were also in the best interest of our customers. Our actions saved residents and businesses hundreds of dollars on their electricity supply costs. Our success throughout this process can only be attributed to the dedication and hard work of so many individuals including the NOPEC Board of Directors, the NOPEC, Inc. Board, the dedicated NOPEC staff, the team at NextEra, and the many community leaders that wrote letters of support on our behalf and worked with us to help share information and updates with their residents.

NOPEC's electric recertification was just the start, however. There were many more successes that we were able to share with our customers and communities. From re-enrolling almost 90% of our transitioned customers back into the electric aggregation, to offering stable, competitive electric and natural gas pricing, continued advocacy to protect Ohio ratepayers, and expanding and launching new programs and initiatives that support economic development, sustainability, and energy-efficiency in NOPEC member communities. NOPEC never wavered in its mission to serve our communities and our customers.

After sharing NOPEC's successes in 2023, it is with a heavy heart that I announce that at the end of 2023, after 18 years serving on the NOPEC Board of Directors, I made the difficult decision to retire from the Board. I am proud and honored to have served such an impactful, mission-driven organization that works so diligently every day in the support and service of Ohio communities and their residents and small businesses. I will continue to support NOPEC's efforts as a NOPEC Ambassador and life-long advocate for this wonderful organization.

NOPEC is a unique organization, focused on helping each distinct member community achieve their individual goals for the future. This report outlines the many initiatives, programs, and benefits that NOPEC's hard-working and committed staff manage on behalf of its 240 member communities, providing energy guidance and expertise, economic development and sustainability support, educating the future energy decision makers of tomorrow, and helping customers and communities conserve energy to save even more. I'm proud to have been a part of NOPEC's growth and impact over the years and wish the organization and its outstanding members all the best for the future.

# WORKING TOGETHER TO PUT CUSTOMERS FIRST

## 2023 PUCO ELECTRIC CERTIFICATE RENEWAL

In August, 2022, NOPEC put our customers first. We temporarily returned over half a million electric customers to the lower cost standard service offer program operated by the electric utilities because it was the most affordable offer for those customers during an extremely volatile time for electric markets. This shielded our customers from the substantial price hikes that happened with many other suppliers throughout the state. Many other electric customers and aggregations also returned to the utilities' lower cost standard service offer in 2022.

While NOPEC acted in compliance with Ohio law and rules in our efforts to ensure our customers would pay less for their electric generation supply through Spring 2023, this action resulted in NOPEC's electric certification through the PUCO being reviewed by the agency and challenged by several of NOPEC's direct competitors. After a thorough review by the PUCO and its staff, the PUCO renewed NOPEC's certificate unconditionally in March



2023. In doing so, the PUCO concluded that NOPEC had not violated any Ohio laws or PUCO rules or orders in returning its customers temporarily to the lower cost utility standard service offer.

During this time, more than a hundred of NOPEC's member community leaders, state legislators, and others wrote letters to the PUCO in support of NOPEC's certification renewal. These letters, demonstrating that so many NOPEC communities supported NOPEC's decision, were a significant factor in our successful recertification.

In March 2023, NOPEC started the complex task of informing, educating, and re-enrolling about half a million customers in over 200 member communities back into NOPEC's electric aggregation program.

## PUBLIC EDUCATION MEETINGS

Once NOPEC announced plans to re-enroll our electric customers, there were many questions and concerns that needed to be addressed. And we rose to the challenge. NOPEC staff presented at over 100 public educational meetings held throughout NOPEC's member communities, meeting with large groups of residents all over the state, answering their questions, hearing their concerns, and talking with them about their energy bills. These public meetings were made possible because the mayors, city council members, service and finance directors, and many others from NOPEC member communities helped us to schedule and advertise these meetings.

At these meetings, NOPEC staff helped to allay the concerns that many residents shared with us. Many meetings ended with hugs and handshakes from attendees as they thanked us for being there to help them understand.

## ELECTRIC RE-ENROLLMENT

In April 2023, NOPEC mailed about 600,000 enrollment letters to eligible electric customers to restart our aggregation in June 2023. We were pleased that nearly 90% of the customers we transitioned temporarily in August 2022 to save them money returned to NOPEC during our re-enrollment and started service again in June 2023.

The events of the past two years have given NOPEC the remarkable opportunity to live our mission to serve our communities and our customers. While the path we took was a difficult one, the decision was easy. We exist to serve, and this situation gave us the opportunity to do just that. It was done in the best interests of our customers to protect them from rising electricity prices. In 2023, as the electric utilities' standard service offers almost doubled, NOPEC was able to come back with rates significantly lower, saving residents and small businesses in NOPEC member communities substantial amounts on their electric bills.

# ONGOING AGGREGATION ENROLLMENT:

NOPEC takes a proactive approach to maintaining every community's full enrollment to ensure the success of each program by conducting refresh mailings each month. These mailings are specifically designed to reach new residents and accounts that have recently concluded their contracts, providing them with timely and relevant information about the community's aggregation program. We also mail enrollment information to all eligible customers in a NOPEC member community every 2 years for natural gas and every 3 years for electric. In fact, in 2023, we mailed over half a million natural gas enrollment letters to eligible natural gas customers in NOPEC communities.

Our enrollment process is meticulously designed to ensure inclusivity, while strictly adhering to the criteria that only eligible accounts within the defined community boundaries are considered. This careful selection process underscores our commitment to precision and fairness, ensuring that our program remains both accessible and relevant to all community members.

# NOPEC'S CUSTOMER CARE CENTER

This past year, our U.S.-based call center has been a cornerstone of our commitment to delivering exceptional customer service, operating 24/7 to ensure our customers have access to support at any hour.

The online chat service available at nopec.org offers customers an immediate and personal way to get help. This platform has allowed us to connect with our customers using another avenue of communication, in real-time, offering solutions and support.

# ENERGY EFFICIENCY FINANCING PROGRAMS

NOPEC's Property Assessed Clean Energy (PACE) and Savings Through Efficiency Program (STEP) offer low-interest rate financing designed to help commercial property owners make energy efficient and/or renewable energy updates to their buildings.

PACE, designed for smaller commercial property owners, nonprofits, and municipalities, funds energy efficiency projects up to \$1,000,000 dollars. Projects could include things like HVAC, roofs, windows, and even solar equipment. With rates as low as 3% and generous repayment timing, this off-balance-sheet financing is incredibly valuable to Main Street businesses and cities alike! STEP offers quick, simple, low-interest loans for energy efficiency improvements starting at a 3% interest rate. STEP covers improvements or replacement for energy efficient aspects of buildings of up to \$125,000, and is one of the most accessible ways a small business, nonprofit, or municipal government can cover their project costs.

# THE CITY OF SOUTH EUCLID

Utilizing the results of a comprehensive energy audit and facility study, the City implemented a number of energy efficiency upgrades including new LED lighting, ADA facility improvements, new HVAC systems, windows, and roofing. The project, completed in 2022, is already having a major impact on reducing the municipality's energy bills.



# THE CITY OF RITTMAN

Working with Verde Solutions, the City developed a plan to create a solar panel field at their wastewater treatment plant. The field is expected to supply approximately 77% of the facility's electricity upon completion. The City's long term goal is to set an example of stewardship and sustainability resources.



## THE CITY OF INDEPENDENCE Honorable Mention

The City's Parks and Recreation Department discovered an opportunity to decrease the energy consumption of eight batterypowered golf carts used throughout the City's park campus with rooftop solar panels. With this project's success, the city is now looking for other improvements for equipment moving forward.

# 2023 GENERAL ASSEMBLY

Community leaders, elected officials, stakeholders, and industry partners came together for NOPEC's 23rd General Assembly Meeting on November 14. In our commitment to accessibility, we continue to offer both in-person and virtual attendance options for this meeting.

Notably enhancing this year's General Assembly, NOPEC introduced a Lunch and Learn session after the meeting where a distinguished industry expert reviewed the intricacies of the energy marketplace and how NOPEC is managing those factors.

#### AGGREGATION UPDATES

Chuck Keiper, NOPEC's Executive Director, provided insight into the unique challenges NOPEC faced this year including NOPEC's unconditional recertification from the PUCO, our outreach and consistent communication with our communities and consumers, and the ultimate re-enrollment of NOPEC's electric customers at a stable, affordable rate.

# SUSTAINABILITY AND COMMUNITY INVESTMENT

Aaron Marcovy, NOPEC's Community Investment & Economic Development Director, gave an update on the past year's community investment and sustainability initiatives. Aaron spoke about the NOPEC Energized Community Grants, Preferred Partner Network, Savings Through Efficiency Program (STEP), and Property Assessed Clean Energy (PACE) Program. We also introduced two new programs—the LED Easy-Bulb Program and the Small Business Energy Audit Program—as well as new



partnerships with the Industrial Heartland Solar Coalition, the Mid-Ohio Regional Planning Commission, the Cleveland 2030 District, World Kinect, and Energy Coalition Ohio. Aaron concluded his speech by welcoming NOPEC's first Director of Resiliency and Sustainability, Deepa Vedavyas. ## NOPEC FOUNDATION

Joseph Ruby, NOPEC Foundation's Board Chairman, recapped the Foundation's first round of charitable donations that took place in 2023. Through a unique partnership with the Cleveland Foundation, the NOPEC Foundation was able to ratify its giving guidelines and policies and sculpt an effective program. Through this partnership, these foundations introduced a never-before-seen decision-making process that included input from a group of NOPEC's staff. In 2023, the NOPEC Foundation reached over \$240,000 in charitable donations to 26 organizations for causes that include social services, food insecurity, environmental initiatives, community development, and more.

## LUNCH AND LEARN

At the conclusion of the General Assembly Meeting, attendees were given the opportunity to stick around for an energy market seminar presented by Doug Condon, NOPEC's Hedging Consultant and Managing Director at Three Rivers Energy. While attendees enjoyed lunch, Doug spoke about the deregulated energy market, how NOPEC manages energy price risk, and factors that affect the price of energy, followed by a Q&A session. NOPEC has been advocating for Ohio residents, businesses, and communities for over 20 years. In 2023, NOPEC continued our advocacy efforts to protect energy consumers from unreasonable utility rate increases and unfair regulation, while preserving consumer choice in Ohio.

# OPPOSING MERGER THAT COULD INCREASE ELECTRICITY PRICES:

Federal Energy Regulatory Commission (FERC) Case No. EC23-74-000

In March 2023, Vistra Corp announced they were acquiring Energy Harbor Corp in a merger transaction. Energy Harbor owns two nuclear power plants in northern Ohio, and both companies compete directly with NOPEC in the Ohio electric aggregation market. NOPEC and others, including the Office of Ohio Consumers Counsel (OCC), intervened and filed protests opposing the proposed merger at FERC, with independent expert studies concluding that the merger will result in increased electricity prices in Ohio. Other parties,

After finding the applicants' initial merger application deficient, Vistra agreed to sell two generation facilities in Ohio and cure the deficiencies. In February 2024, FERC approved the merger application with conditions, including the sale of the two generating plants. NOPEC intends to monitor the merged companies' future activities in Ohio to protect Ohio consumers from price increases as a result of the merger.

# OPPOSING DOMINION ENERGY OHIO RATE INCREASE:

#### Public Utilities Commission of Ohio (PUCO) Case No 23-23-894-GA-AIR et al

In September 2023, Dominion Energy Ohio filed a notice with the PUCO to increase its gas distribution rates in Ohio by about \$275 million per year. NOPEC has intervened in the case and is opposing the rate increase, together with other intervenors including the OCC. It is expected that hearings will be held in the 3rd quarter of 2024.

#### INCREASING RENEWABLE ENERGY DEVELOPMENT IN OHIO:

Ohio Legislature- Substitute HB 197-Community Solar in Ohio

HB 197 would authorize the development of Community Solar developments in the state of Ohio. NOPEC has been working with the bill's sponsoring organizations to support this bill which would increase renewable energy development in Ohio. The bill is currently pending in the Ohio House of Representatives.

## ADVOCATING FOR CUSTOMER REFUNDS FOR ILLEGAL PAYMENTS:

PUCO Case 17-974-EL-UNC et al. (FirstEnergy PUCO audit cases regarding HB 6 payments)

NOPEC has filed to intervene in the four audit case investigations opened by the PUCO regarding unlawful payments made by FirstEnergy in connection with the HB 6 scandal involving former FirstEnergy executives, former PUCO Chair Randazzo, former Ohio Speaker of the House and former lobbyists for FirstEnergy. Together with other parties in the case, NOPEC will be advocating for customer refunds if the audits and discovery in the case reveal that customers have been charged for illegal payments made by the company.

# TOGETHER, WE HELP PROTECT OUR PLANET

NOPEC remains committed to supporting sustainability efforts within our communities. In 2023, we expanded our sustainability offerings to include resources for small businesses and residents as well as municipalities. Through the creation of programs like the LED Easy-Bulb Program and NOPEC's Small Business Energy Audit Program, we are intent on making sustainability resources accessible for all.

## SUPPORTING RENEWABLE ENERGY DEVELOPMENT

NOPEC offers a variety of programs for communities, residents, and small businesses that support the development of renewable energy projects in the U.S. and Ohio. These include multiple electric program options backed by Renewable Energy Credits for 100% of the electricity used for residents and small businesses. Communities can even get 100% renewable energy content electricity at cost for their municipal loads. In 2023, NOPEC retired 287,000 RECs for a total of over 9.9 million RECs retired since 2017.

In addition, NextEra Energy Resources ("NextEra") contributes a portion of the NOPEC aggregation revenues to the EarthEra® Renewable Energy Trust (EarthEra® Trust). Funds from the trust are used to develop NextEra renewable energy projects in the United States, including Ohio. Since 2017, NextEra has contributed nearly \$100 million from NOPEC's aggregation programs into the EarthEra® Trust.

NOPEC continues to work with NextEra to identify opportunities in Ohio to expand the renewable energy capacity in the state.

#### GREEN COMMUNITY CHOICE PROGRAM

Through this program, communities elect to make a renewable energy option, via Green-e<sup>®</sup> Energy Certified Renewable Energy Credits, the default electric program for their community. Starting in June 2023, South Euclid, Sheffield Village, Cleveland Heights, and Lakewood were the first communities to participate in the Green Community Choice Program.

# SUSTAINABILITY FOR SMALL BUSINESSES

In 2023, NOPEC listened to small businesses. We found that many small businesses were eligible for energy efficiency financing but did not have the resources to complete a common prerequisite—an energy audit. In response, we created the Small Business Energy Audit Program through which small businesses in NOPEC communities are eligible to receive grants of up to 100% of the costs associated with securing an energy audit. We also established NOPEC's Preferred Partner Network to provide small businesses with a list of trusted energy audit partners who have committed to an elevated response time and high quality of service.

## SUSTAINABILITY PARTNERSHIPS

In 2023, NOPEC formed meaningful connections and partnerships with organizations that share our passion for sustainability. We became the only governmental aggregation to sign the Industrial Heartland Solar Coalition, a multi-state proposal to the EPA to help facilitate federal funds to be spent on solar

initiatives across the Midwest We also became the only government aggregation to be a member of the Cleveland 2030 District, an organization dedicated to reducing the environmental impact of building construction and operations. We assisted in the facilitation of both the Mid-Ohio Regional Planning Commission's Summit on Sustainability and the Ohio Energy Conference, moderating discussions on grassroots ways to enhance sustainability and resiliency in Ohio. Plus, working with World Kinect Energy Services, NOPEC is piloting the new Sustainability Technical Assistance Resources (S.T.A.R.) Program that would provide our communities with a road map and the resources necessary to pursue their decarbonization and energy efficiency goals through in-depth carbon inventories of municipal buildings, solar readiness site assessments, and technical sustainability guidance.
